

## 【AIRSIDE 足球遊樂場 (「活動」) 條款及細則】

1. 活動日期：2026 年 6 月 11 日至 7 月 16 日。
2. 活動地點: AIRSIDE 6 樓空中花園
3. 活動地點開放時間：中午 12 時至晚上 6 時
4. 活動或因任何原因而更改舉行日期、開放時間、地點、參加人數及方式或取消而毋須事先通知或補償，詳情請留意 AIRSIDE Facebook 或 Instagram 專頁或場內的任何公布。

5.
